Interestingly, many are from out of state and at least one is from Canada. Richard has sent out an email asking for help from the community in writing letters or emails with positive comments on the good and helpful work mosquito abatement districts do.

Richard reports there has been an issue with some of the lighting at our building, and he has contacted someone to service it. He also reports he hasn't heard anything yet on when the new truck might arrive.

Administrative Manager Debbie Mays gave out information on this month's bills as well as our 2022 budget position. She reminded trustees of the need to complete an Ethical Behavior Pledge form for 2022 and, if needed, a Conflict of Interest Disclosure form.
